ORDINANCE ADDRESSING FLOODPLAIN MANAGEMENT PROVISIONS OF THE STATE CONSTRUCTION CODE

An Ordinance addressing flood plain management provisions of the State Construction Code; affirming Hopkins Township as the enforcing agency for the flood plain management provisions of the State Construction Code; designating the Hopkins Township Building Official as the contact point for the discharge of said flood plain management responsibilities; designating regulated flood hazard areas under the provisions of the State Construction Code, being Act No. 230 of the Public Acts of 1972, as amended.

THE VILLAGE OF HOPKINS ORDAINS:

SECTION I

AGENCY DESIGNATED

Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Hopkins Township Building Official is hereby designated as the enforcing agency to discharge the responsibility of Hopkins Township under Act 230, of the Public Acts of 1972, as amended, State of Michigan. Hopkins Township has assumed responsibility for the administration and enforcement of said Act throughout its corporate limits.

SECTION II

CODE APPENDIX ENFORCED

Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, and Appendix G of the Michigan Building Code, Hopkins Township affirms its designation as the administering and enforcing agency for the State Construction Code within the corporate limits thereof and in accordance therewith designates the Hopkins Township Building Official as the enforcing agent to discharge the responsibilities of the Municipality therewith.

SECTION III

DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS

The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled "Flood Insurance Study for Allegan County, All Jurisdictions", dated June 21, 2023 and the Flood Insurance Rate Map(s) (FIRMs) contained on index panel number 26005CIND0A, dated June 21, 2023 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code.

SECTION IV

REPEALS

All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

SECTION V
