1. **Call to Order** - President Price called the meeting to order at 7:32pm.

4. **Agenda Presentation** - Buist motioned to approve agenda of 01/12/2026 as presented, Pawlowski supported, **motion carried**.
5. **Mike Alberda Resignation** - Buist motioned to accept Mike Alberda's resignation as Village Clerk, Pawlowski supported, **motion carried**.
6. **Danielle Westhouse Resignation - Trustee and Secretary** - Buist motioned to accept Danielle Westhouse's resignation as Trustee and Village Secretary, Pawlowski supported, **motion carried**.

 - Flower installations for six light posts
 - Watering solutions and equipment
 - Proposed timeline beginning in March
 - Potential support from Hopkins Lions Club or sponsors

Ms. Erickson indicated she would set up the project but noted it would need a successor for ongoing maintenance.

Council agreed to discuss the proposal further within committees and make a decision in **February**.
